Addendum to PPA Administrative Order No. 01 - 2007

Expanding the Jurisdictional Area of Iloilo Pilotage District

In addition to the North Panay Ports designated under the jurisdictional/operational area of Iloilo Pilotage District as prescribed under PPA Administrative Order No. 01-2007, the Semirara Islands is hereby declared to form part of the North Panay Ports in view of its proximity to the area.

As such, the following are the coordinates representing the geographical location of Semirara Islands, including its Pilots' Boarding Station and Loading Port:

1. <u>Semirara Islands</u>

Lying off South end of Mindoro and extending 28 miles SE of Buruncan Point at Lat. 12° 13.0' N – Long. 121° 15.0' E.

2. Pilots' Boarding Station

Lat. 12° 03.5' N Long. 121° 19.0' E.

3. Loading Port

Lat. 12° 03.24′ N Long. 121° 21.0′ E
