SUBJECT **Increase in Domestic Roll-on-Roll-off (RO-RO) Rates/Charges**

In order to cushion the impact of the present economic crisis brought about by the devaluation of the Philippine peso and the subsequent increase in wages, ro-ro rates under PPA Administrative Order No 05-95 were granted a twenty per cent (20%) upward adjustment pursuant to PPA Board Ex-Com Resolution No 98-560 as confirmed by Board Resolution No 1709. The new rates under the said order are prescribed, as follows:


