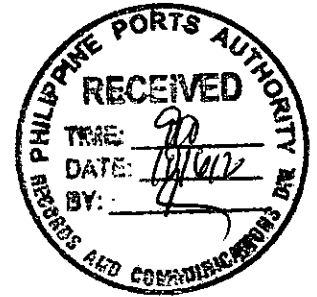

PPA MEMORANDUM CIRCULAR
NO. 13 2012



TO : All PDOs/PMOs, Harbor Pilots/Pilots' Associations,
Shipping Companies/Agents, Cargo Handlers and
Others Concerned

SUBJECT : DESIGNATION OF ANCHORAGE AREAS IN THE
ISLAND OF BORACAY, MALAY, AKLAN

1. **AUTHORITY**

- 1.1 Sections 6-a (ii), (x), 26 and 28 of Presidential Decree No. 857
- 1.2 Section 15 of PPA Administrative Order No. 13-77 entitled "General Port Regulations of the Philippine Ports Authority"

2. **SCOPE**

This Memorandum Circular shall cover all vessels calling at the Caticlan Jetty Port.

3. **OBJECTIVE**

To facilitate the monitoring of marine operations and to ensure safe and smooth flow of vessel traffic in the waters of Caticlan/Boracay Island.

4. **GUIDELINES**

- 4.1 The anchorage areas where vessels can safely anchor within the Island of Boracay during Northeast and Southwest monsoons are hereby established with the following coordinates:

Northeast Monsoon - Lat 11° 55' .8 N
Long 121° 56' .0 E

Southwest Monsoon - Lat 11° 59' .0 N
Long 121° 56.25 E

- 4.2 No vessel shall anchor or use the anchorage areas other than the purpose for which said areas are intended.

VISION

By 2030, customers doing business in our ports shall experience full and sustained productivity, efficiency comfort, connectivity, safety and security.

MISSION

We commit to provide reliable and responsive services in our ports, sustain development of our port communities and environment and be a model corporate agency of the government.

- 4.3 No vessel shall anchor, moor, lie or obstruct the approaches to the designated anchorage areas and/or be in a position which is likely to foul up another vessel already anchored or moored thereat.
- 4.4 All vessels anchoring in the Boracay anchorage areas shall secure the necessary entrance and departure/exit clearances from the PPA Port Management Office of Iloilo.
- 4.5 The pertinent provisions of PPA MC No. 11-96 entitled "Designation of Anchorage Grounds at PMO Baseports," insofar as applicable, shall be observed/complied with by all concerned.

5. REPEALING CLAUSE

All PPA orders, rules and regulations, circulars or parts thereof which are inconsistent with this Memorandum Circular are hereby repealed or modified accordingly.

6. EFFECTIVITY

This Circular shall take effect immediately.
