Addendum to Annex "A" of PPA Administrative Order No. 03-85 Entitled "Rules and Regulations Governing Pilotage Services, the Conduct of Pilots, and Pilotage

Fees In Philippine Ports"

AUTHORITY .1.

Section 6-a (viii) of P.D. 857 1.1

1.2 Section 6, Article II of PPA AO No. 03-85

2. SCOPE

This Order shall cover all vessels calling at the ports within the North Panay Area.

OBJECTIVE 3.

To expand the jurisdictional/operational area of the Iloito Pilotage District covering the ports within Northern Panay in view of the absence of pilotage services thereat.

GUIDELINES 4.

4.1 Jurisdictional Area of Iloilo Pilotage District

Item 11 (Iloilo Pilotage District) of Annex "A" to Section 6, Article II of PPA AO No. 03-85 is hereby modified to read as follows:

"11. Iloilo Pilotage District

Shall embrace all the waters between Panay and Guimaras Islands bounded on the West by a line drawn from Lat. 10° 29.0' N - Long. 122° 28.5' E to Lat. 10° 40.0' N - Long. 122° 22.0' E and on the East by a line drawn from Lat. 10° 43.0' N - Long. 122° 42.5' E to Lat. 10° 47.0' N-Long. 122° 44.0' E - comprising the ports and harbor of Iloilo City Lat. 10° 41.8' N - Long. 122° 34.5' E and the Iloilo River; the Port of Estancia, Iloilo Lat. 11° 27.0' N - Long. 123° 09.0' E; the Port of Roxas City, Capiz Lat. 11° 36.0' N - Long. 122° 42.0' E; the Port of Batan, Aklan Lat. 11° 56.0' N - Long. 122° 29.0' E, the Port of New Washington, Aklan Lat. 11°

4.3 Establishment of Pilotage Office at North Panay Area

The Pilotage Association concerned shall be required to put up an office at North Panay area in order to provide timely pilotage services and limit transportation cost by the pilots on duty.
