SUBJECT : **STANDARDIZED ACCREDITATION FEE OF PPA AO NO. 06 - 2019**

1. AUTHORITY

- 1.1 Section 20 (a), Article VII of PD 857, Revised Charter of PPA.
- 1.2 PPA Board Resolution No. 2812 dated 27 June 2019.

2. OBJECTIVES

- 2.1 To standardize the accreditation fee in the issuance of accreditation certificates for Port Service Providers
- 2.2 To promote efficient and effective port operations and services in all ports under the jurisdiction of PPA.
- 2.3 To ensure legitimacy, capability and competency in the provision of port services thru PPA accreditation.

3. PROVISION

In order to have standard and uniform charges in the issuance of accreditation certificate the following rates are hereby prescribed:
