PPA MEMORANDUM ORDER NO. 021 -2023

- TO : All Port Managers Others Concerned
- SUBJECT : Revocation of PPA Administrative Order (AO) No. 10-2020 entitled "Reduction of Port Charges for Foreign Ships Deviating to Port of Capinpin, Orion, Bataan for Crew Change"

In view of the Proclamation No. 297 issued by the President of the Philippines lifting the state of public health emergency throughout the Philippines due to COVID-19, PPA AO No. 10-2020, otherwise known as *"Reduction of Port Charges for Foreign Ships Deviating to Port of Capinpin, Orion, Bataan for Crew Change"* is hereby revoked.

As such, PMO-Bataan/Aurora shall have ceased the granting of the 50% reduction of port charges (*Port Dues, Dockage-at-Anchorage, Dockage-at-Berth, and Lay-up Fee*) to foreign vessels undertaking change of crew at the Port of Capinpin, Orion, Bataan.

Further, using the attached sample format, PMO-Bataan/Aurora shall submit a report to the Office of the General Manager, Attention: CSD, on November 6, 2023, on the total foregone revenue because of this undertaking from December 11, 2020, the effectivity of PPA AO No. 10-2020 until the lifting of the Presidential Proclamation No. 222. S. 2020 through Proclamation No. 297 by the President of the Philippines on July 21, 2023.

All previous orders and issuances inconsistent herewith shall be deemed revoked.

This Order shall take effect immediately.
