**SUBJECT : Amendments to PPA Memorandum Circular (MC) No. 06-
2022 Re: Revised Schedule of Cargo Handling Tariffs at the
Manila South Harbor and Manila International Container
Terminal, Inc. (MICT)**

To standardize the currency in billing the international shipping lines, PPA MC No. 06-2022 is hereby amended to cover the Empty Handling Fees for foreign empty containers in US Dollar-denominated vessel charges at the Manila South Harbor and MICT using the same conversion rate of Php44.50 per US Dollar prescribed under PPA MC No. 10-2009, as follows:

- e) gang cancelled by client due to instances other than the above.
