SUBJECT Increase In Domestic Port Charges

Pursuant to the Philippine Ports Authority Board Resolution No 1709 dated 27 April 1998, and the Memorandum from the Office of the President dated January 8, 2001, the domestic port charges are hereby increased as follows

- A2Registered bay and river trade vessels shall also be charged one-half (1/2) of the required Domestic Dockage Fee but in no case less than or more than the following charges for a calendar day or fraction thereof

B3 Domestic cargoes, whether containerized or not, that are loaded/discharged at anchor without using any government wharf or at officially registered private ports shall be charged one-half (1/2) of the usual Domestic Wharfage Fee

The Circular shall be published once a week for two (2) consecutive weeks in two (2) newspapers of general circulation and the new rates shall take effect Feb 25, 2001, Feb 25, 2002, Feb 25, 2003, Feb 25, 2004 and Feb 25, 2005

This amends/supersedes PPA Memorandum Circular No 07-94 as far as the domestic port charges are concerned
