SUBJECT: CLARIFICATORY GUIDELINES ON EXECUTIVE ORDER NO. 1088 ENTITLED, "Providing for Uniform and Modified Rates for Pilotage Services Rendered to Foreign and Coastwise Vessels in Ali Private or

Public Philippine Ports"

Pursuant to Board Resolution No. 1663, as adopted on July 21, 1997 and the January 22, 1997 Decision of the Supreme Court which has resolved with finality the validity of Executive Order No. 1088 dated 03 February 1986, the authorized/applicable rates for pilotage shall be those prescribed under said EO 1088, effective 03 February 1986. The same rates are inclusive of premium or overtime whether pilotage services are rendered during Sundays, holidays and nighttime (1800H - 0600H).

All PPA orders, rules and regulations, circulars or parts thereof which are inconsistent with this Circular are hereby repealed or modified accordingly until new regulations are issued by this Authority.

EXECUTIVE ORDER NO. 1088

PROVIDING FOR UNIFORM AND MODIFIED RATES FOR PILOTAGE SERVICES RENDERED TO FOREIGN AND COASTWISE VESSELS IN ALL PRIVATE OR PUBLIC PHILIPPINE PORTS.

WHEREAS, the United Harbor Pilots' Association of the Philippines has clamored for the rationalization of pilotage service charges, through the imposition of uniform and adjusted rates for foreign and coastwise vessels in all Philippine ports, whether public or private;

WHEREAS, the plea of the Association has been echoed by a great number of Members of Parliament and other persons and groups;

NOW, THEREFORE, I, FERDINAND E. MARCOS, President of the Philippines, by virtue of the powers vested in me by the Constitution and by law, do hereby direct and order:

SECTION 1. The following shall be the rate of pilotage fees or charges based on tonnage for services rendered to both foreign and coastwise vessels;

Over 140,000 gross tonnage \$0.05 or its peso equivalent for every excess tonnage. Rate for docking and undocking, anchorage, conduction and shifting and other related special services is equal to 100%. Pilotage services shall be compulsory in government and private wharves or piers.

- SEC. 2. With respect to foreign vessels, payment of pilotage services shall be made in dollars or in pesos at the prevailing exchange rate.
- SIC. 3 All orders, letters of instruction, rules, regulations and other issuances inconsistent with this Executive Order are hereby repealed or amended accordingly.
- SEC 4. This Executive Order shall take effect immediately.
