Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the BAC – Engineering Projects, PPA, PMO-Zamboanga, Port Area, Zamboanga City and inspect the Bidding Documents at the address given below from 8:00AM to 5:00PM, Monday to Friday, exclusive of Holidays.
