Bidders shall bid on all of the lots enumerated above. Bids received in excess of the Lot Price shall be automatically rejected at bid opening.

PPA now invites bids for the supply and delivery of the above-mentioned items. Delivery is required *ninety-three (93) calendar days from the issuance of the Notice to Proceed*. Bidders must have an experience of having completed, *at least one (1) contract* that is similar to the contract to be bid. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested Bidders may secure the bidding documents starting **July 27, 2016 to August 16, 2016** upon payment of a non-refundable fee in the amount of **One Thousand One Hundred Twenty Pesos (P 1,120.00)**, inclusive of 12% VAT at PPA, PMO Eastern Leyte/Samar, Port Area, Tacloban City during regular office hours and obtain further information from BAC-PG Secretariat:

PPA will hold a **Pre-Bid Conference on August 3, 2016 at 10:00am** at PPA Conference Room, which shall be *open only to all interested parties who have purchased the Bidding Documents*.

Submission of Bids. Bids must be addressed to the Chairperson BAC-PG, submitted to and duly received by the BAC-PG Secretariat **not later than 9:00a.m. (PPA, PMO-ELS Time) August 16, 2016.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the **Instruction to Bidders**.

Opening of Bids shall be on **August 16, 2016, 10:00am** at the PPA, PMO- Conference Room, Port Area, Tacloban City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the aforesaid address. **Late bids** shall not be accepted.

PPA reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
