INVITATION TO BID

The Philippine Ports Authority, Port Management Office of Zamboanga (PPA, PMO-Zamboanga) through its Bids and Awards Committee for Procurement of Goods (BAC-PG) invites interested bidders to participate in the public bidding and submit their eligibility requirements and bid documents for the project stated below. Bids received in excess of the ABC shall be automatically rejected at Bid Opening.

1. Name of Project: One (1) Lot Supply of Materials, Labor & Equipment for the Provision of One (1) unit Diesel Generator Set, 75 KVA, Silent Type, Brand New, including its delivery on site and Wiring Installation at Admin. Building, PPA, PMO-Zamboanga, Zamboanga City.
2. Duration: Sixty (60) calendar days
3. Approved Budget for the Contract (ABC): NINE HUNDRED EIGHTY THOUSAND PESOS ONLY (Php980,000.00)
4. Source of Fund: PPA Corporate Fund
5. Scope of Work - The project shall include the following:
 - a. Supply of Materials, Labor & Equipment for the Provision of One (1) unit Diesel Generator Set, 75 KVA
 - b. Delivery on site
 - c. Supply of Materials, Labor and Equipment for the Wiring Installation
6. Location of Delivery – Admin. Building, Philippine Ports Authority, PMO-Zamboanga, Zamboanga City
7. Warranty Period - At least one (1) year
8. Cost of Non-Refundable Bidding Documents: Php1,120.00 (inclusive of 12% VAT)

All bids shall be inclusive of the applicable Value Added Tax (VAT). The evaluation and contract award shall be **based on a one (1) whole lot**.

Bidders must have an experience in undertaking at least one (1) project/contract similar to the contract to be bid. The contract amount of the said completed similar contract should be equivalent to at least 50% of the ABC to be bid.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from PPA, PMO-Zamboanga and inspect the Bidding Documents at the address given below during office hours from 8:00 AM to 5:00 PM, Monday to Friday except on holidays.

Documents will be issued to the interested bidders upon receipt of the Letters of Intent (LOI) and payment of a non-refundable amount of **ONE THOUSAND ONE HUNDRED TWENTY PESOS**, Philippine Currency (**Php1,120.00**), inclusive of 12% VAT.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Upon submission of bid documents, bidder's representative is required to present a copy of the Special Power of Attorney to represent the owner/s of the company. Late bids shall not be accepted.

The PPA, PMO-Zamboanga reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
