
Important reminders for the Prospective Bidders:

 On the submission of Bid Documents


Bidders shall submit their Bid Documents in two (2) separate sealed Bid Envelopes. The First Envelope is the Technical Proposal containing seven (7) copies, one (1) original and six (6) duplicate copies each individually wrapped in an envelope then sealed in an outer envelope.

The Second Envelope is the Financial Proposal which contains seven (7) copies, one (1) original and six (6) duplicate copies each likewise individually wrapped in an envelope and shall all be sealed in an outer envelope.





The Bid Documents shall be hard bound, book bound properly labelled with index tabs. Failure to comply with the requirement is a ground for the automatic disqualification of the bidder.







- 2. the veracity of the statements and information contained therein;
- that the Certificate is not a guaranty that the named registrant will be declared eligible without first being determined to be such for that particular bidding, nor is it an evidence that the Bidder has passed the post-qualification stage; and
- 4. that any finding of concealment, falsification, or misrepresentation of any of the eligibility documents submitted, or the contents thereof shall be a ground for disqualification from further participation in the bidding process, without prejudice to the imposition of appropriate administrative, civil and criminal penalty in accordance with the laws.

REMINDERS 1

- The PhilGEPS office shall not determine the eligibility of merchants. The PhilGEPS office's evaluation
 of the eligibility requirements shall be for the sole purpose of determining the approval or disapproval
 of the merchant's application for registration
- A merchant's registration and membership in the GOP-OMR is neither contract-specific nor
 understood to be tantamount to a finding of eligibility. Neither shall the merchant's successful
 registration in the GOP-OMR be relied upon to claim eligibility for the purpose of participation in any
 public bidding.
- The determination of the eligibility of merchants, whether registered with the GOP-OMR or not, shall
 remain with the Bids and Awards Committee (BAC). The BAC's determination of validity of the
 eligibility requirements shall be conclusive to enable the merchant to participate in the public bidding
 process.
