INVITATION TO BID FOR REPAIR / REPLACEMENT OF EXISTING PTB CANOPY PORT OF TAGBILARAN, TAGBILARAN CITY

The Philippine Ports Authority, through the Corporate Budget of the Authority for CY 2016, intends to apply the sum of Pesos: One Million Nine Hundred Sixty-seven Thousand Five Hundred Ten and 13/100 (₽ 1.967.510.13) being the Approved Budget for the Contract (ABC) to payments under the contract for the Repair /Replacement of Existing PTB Canopy, Port of Tagbilaran, Tagbilaran City (A160137). Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Philippine Ports Authority now invites bids for the following scope of work:

- A. Mobilization/Demobilization
- B. Repair/Replacement of Existing PTB Canopy

Completion of the Works is required in 90 calendar days. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents. particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using nondiscretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the Bids and Awards Committee and inspect the Bidding Documents at the address given below from 8:00 A.M. to 5:00 P.M.

A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of FIVE THOUSAND PESOS (₽ 5,000.00) per PPA Memorandum Circular No. 10-2012 dated September 19, 2012.

The Bids and Awards Committee will hold a Pre-Bid Conference on 22 November 2016 at 2:00 P.M. at the PPA Administration Building, PPA, PMO- Bohol, Port Area, Tagbilaran City, which shall be open to all interested parties who have purchased the Bidding Documents.
