**INVITATION TO BID**

FOR THE:

**INSTALLATION OF SOLAR LIGHTING SYSTEM AT TMO-PASIG, SOUTH HARBOR, PORT AREA, MANILA.**

The Philippine Ports Authority, PMO - NCR South, through the Corporate Budget of the Authority for CY 2019, intends to apply the sum of **P 4,419,476.54** being the Approved Budget for the Contract (ABC) to payments under the contract for the **INSTALLATION OF SOLAR LIGHTING SYSTEM AT TMO-PASIG, SOUTH HARBOR, PORT AREA, MANILA. (PMO-NCR South-C190011)**. Bids received in excess of the ABC shall be automatically rejected at the bid opening.

The Philippine Ports Authority now invites bids for the following Scope of Works:

1. GENERAL EXPENSES
2. SOLAR STREET LIGHTINGS

Completion of the Works is required in **SEVENTY (70) CALENDAR DAYS**. Bidders should have an experience of having completed at least one (1) contract that is similar to the contract to be bid. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

The Minimum Equipment Requirement (Owned/Leased) for this project are:

1. 1-Unit Truck mounted telescopic boom type crane (2-5 tons cap., 100hp)
2. 1-Unit One bagger concrete mixer
3. 1-Unit Concrete Vibrator (1" shaft w/ 3.5hp)
4. 1-Unit Air compressor w/ 1 breaker, 125cfm
5. 1-Unit Water pump (output discharge 2,667 lpm, 16hp)
6. 1-Unit Concrete cutter, 5hp
7. 1-Unit Bar cutter, manual
8. 1-Unit Bar bender, manual
9. 1-Unit Welding machine 500Amp (Gas Driven)
10. 1-Unit Oxy/acetylene cutting outfit
11. 1-Unit Elf truck (2 ton)
12. 1-Unit Multi-speed electric grinder

This project will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the Bids and Awards Committee and inspect the Bidding Documents at the address given below from 8:00 a. m. to 5:00 p.m.

A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of **FIVE THOUSAND PESOS (P 5,000.00), VAT inclusive.**

It may also be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

Only the duly Authorized Representatives are allowed to purchase the Bidding Documents, to attend the Pre-Bid Conference and the Opening of Bids.

The Bids and Awards Committee will hold a Pre-Bid Conference on **June 11, 2019 at 2:00 P.M.** at the Conference Room, 2<sup>nd</sup> Floor, PPA, PMO-NCR South, Administration Building (formerly Marsman Bldg.), South Harbor, Port Area, Manila, which shall be open to all interested parties who have purchased the Bidding Documents.

Bids must be delivered to the address below on or before **1:00 P.M. of June 25, 2019.** All bids must be accompanied by a Bid Security in accordance with Section 27.2 of the Revised IRR of R.A. 9184. Bids will be opened in the presence of the bidder's representatives who choose to attend at the Conference Room, 2<sup>nd</sup> floor, PPA, PMO-NCR South, Administration Building (formerly Marsman Bldg.), South Harbor, Port Area, Manila on **June 25, 2019 at 2:00 P.M.** Late bids shall not be accepted.
