The Philippine Ports Authority PMO NCR South, through its Bids and Awards Committee (BAC PGRS) and availing of its Corporate Operating Budget, intends to apply the sum of **TWENTY THREE MILLION TWO HUNDRED SIXTY EIGHT THOUSAND SEVEN HUNDRED THIRTY ONE PESOS & 51/100** (₱ 23,268,731.51) being the Approved Budget for the Contract (ABC) to payments under the Contract for Manpower Services for PMOs NCR South and Bataan/ Aurora from August 01, 2017 to July 31, 2018. Bids received higher than the ABC shall be automatically rejected at bid opening.
- 2. The PMO NCR South BAC-PGRS now invites bids from prospective bidders for the Procurement of Manpower Services for PMOs NCR South and Bataan/Aurora to be rendered from August 01, 2017 to July 31, 2018 for the following offices:

Prospective Bidders should have completed, within the last ten (10) years from the date of submission and receipt of bids, a single contract that is similar to the Contract, the value of which must be at least fifty percent (50%) of the present Approved Budget for the Contract (ABC). The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section III, Instructions to bidders. A similar contract shall involve the deployment of positions in the field of Engineering, Accountancy, Information Technology, Logistics, Administrative and the like.

- 4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, known as the "Government Procurement Reform Act", and is restricted to duly licensed Filipino citizens/sole proprietorships, partnerships, or organizations duly organized under the laws of the Philippines and wholly owned by citizens of the Philippines
- 5. Interested bidders may obtain further information and inspect and/or purchase Bidding Documents from 8:00 A. M. to 4:00 P.M. at the address given below from June 07, 2017 until June 28, 2017 upon payment of a non-refundable fee in the amount of Eleven Thousand Two Hundred Pesos Only (P11,200.00), inclusive of VAT thereof:

All bidders even those who did not buy bid documents are allowed to raise or submit written queries/clarifications during the Pre-bid conference.

Bids must be delivered to and received by the Secretariat of the PMO NCR South BAC-PGRS at the PMO-NCR South Conference Room M, Mezzanine Floor, PMO Building, 22 Muelle de San Francisco, South Harbor, Port Area, Manila not later than 9:00 A.M. on June 28, 2017. Late bids shall not be accepted. All bids must be accompanied by a Bid Security in any of the following acceptable forms and amounts in Philippine Currency:
