Rebong, Philippine Ports Authority, PMO-Bataan/Aurora Port Operations Bldg., Brgy.Lamao, Limay, Bataan.

8. The bidder who has the highest bid offer on each of the individual items/lots and which is most advantageous to the government shall be declared the Successful Bidder for that particular item/lot.

9. Within seven (7) working days upon receipt of the Notice of Award (NOA) and after paying the full amount, the winning bidder shall haul/pick-up the unserviceable properties. Failure to do so shall constitute a sufficient ground for cancellation of the award.

10. The Philippine Ports Authority, PMO-Bataan/Aurora reserves the right to reject any or all of the bids with or without cause, to annul the auction process, to waive any defect in them and to award the bidder whose bid is the most advantageous to the government.
