



**INVITATION TO BID
(RE-BIDDING)**

The Philippine Ports Authority - Port Management Office of Batangas, through its Bids and Awards Committee, invites contractors registered with and classified by the Philippine Contractors Accreditation Board (PCAB) to bid for the hereunder contract:

Name of Contract : Underdeck and Underwater Survey/Investigation of R.C. Pier and Wharf
 Location : Port of Tablas, Romblon and Ambulong, Romblon
 Contract Identification/ Reference Number : PMOB – R & M 2018 - 03

Brief Description : The project involves the underdeck and underwater investigation of R.C. pier, wharf and ro-ro ramp of Port of Tablas (1,404.00 sq.m.), Port of Romblon (1,464.00 sq.m.) and Port of Ambulong (750.00 sq.m.)

Required Equipment:

2 units - Motorized Banca (Owned/Leased)
 4 units - Diving Equipment (complete w/ water suit, mask, regulator, depth gauge, dive computer, booties, weight belt, buoyancy compensator, etc.) (Owned/Leased)
 1 unit - Underwater Digital Camera w/ Lighting (Owned/Leased)
 1 unit - Underwater Video Camera (Owned/Leased)
 4 units - Modular Pontoon Platform (Owned/Leased)

Approved Budget for the Contract (ABC) : PHP 2,036,361.60
 Source of Fund : PPA Corporate Fund, (R & M – 2018)
 Contract Duration : 45 calendar days
 Required PCAB Registration : “Small B” for Ports, Harbor and Offshore Engineering

Only those contractors with PCAB Registration of at least “Small ‘B’ Port, Harbor and Offshore Engineering” will be issued Bidding Documents, and upon payment of non-refundable cost of the documents in the amount of P5,600.00 inclusive of VAT. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids. Interested contractors are required to present a certified copy of their PCAB registration when purchasing the Bidding Documents.

Prospective bidders should possess a valid PCAB license and registration particulars applicable to the type and cost of the contract to be bid, have key personnel and equipment available for the prosecution of the contract as listed above, and must have completed at least one (1) contract that is similar to the contract to be bid, and with the same major categories of work as the contract to be bid, and whose value is at least 50% of the approved budget for the contract to be bid, updated to current prices using the NSO consumer price indices. Prospective bidders must likewise meet the other eligibility, technical/project and financial requirements and other requirements stated in the Eligibility Statement Forms and the Bidding Documents.

Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criteria as specified in the IRR of RA 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least 75% interest or outstanding capital stock belonging to citizens of the Philippines.

The Philippine Ports Authority – Port Management Office of Batangas reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders. The Philippine Ports Authority- Port Management Office of Batangas assumes no responsibility whatsoever to compensate or indemnify the bidders of any expenses incurred in the preparation of their bids.
