Only those contractors with at least "Small "B" - for Irrigation and Flood Control " PCAB registration particulars will be issued Eligibility Statement Forms and Bidding Documents, and upon payment of non-refundable cost of the documents in the amount of P 5,600.00 inclusive of 12% VAT.

Prospective bidders should possess an Environmental Compliance Certificate (ECC) issued by Environment Management Bureau for disposal facility/sanitary landfill and Memorandum of Agreement (MOA) with Local Government Unit or private entity regarding disposal facility, a valid PCAB license and registration particulars applicable to the type and cost of the contract to be bid, have key personnel and equipment available for the prosecution of the contract as listed above, and must have completed a contract similar to the contract to be bid and with the same major categories of work as the contract to be bid, and completed within five (5) years from the date of submission and receipt of bids with a value of at least 50% of the approved budget for the contract to be bid, updated to current prices using the NSO price indices, and must meet the other eligibility and bid requirements stated in the Eligibility Statement Form and Bidding Documents.

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criteria as specified in the IRR of RA 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least 75% interest or outstanding capital stock belonging to citizens of the Philippines.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Philippine Ports Authority – Port Management Office of Batangas reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all Bids at any time prior to contract award without thereby incurring any liability to the affected bidder or bidders.
