



INVITATION TO BID

The Philippine Ports Authority - Port Management Office of Batangas, through its Bids and Awards Committee, invites contractors registered with and classified by the Philippine Contractors Accreditation Board (PCAB) to bid for the hereunder contract:

- Name of Contract : Repair of RO-RO Ramp & Back-Up Area, PTB, Fence, Lighting System & Removal of Damaged/Collapsed Breasting Dolphins
- Location : Port of San Juan, Batangas

- Brief Description : The project involves repair of one (1) unit ro-ro ramp including fender system four (4) units, installations of interlocking concrete blocks pavement to newly reclaimed back-up area 1,129 sq.m., repair/repainting of passenger terminal building, repair of pre-cast concrete perimeter fence 565 ln.m., repair of lighting systems it includes removal & replacement of solar powered roadway lighting system eleven (11) sets and one (1)-unit high mast tower with eight (8)-set solar powered floodlights lighting fixtures & accessories, removal and disposal of damaged collapsed breasting dolphins and, repair of reinforced concrete guardhouse two (2) units.

Only those contractors with PCAB Registration of at least "Medium 'A' for Ports, Harbor and Offshore Engineering and Small 'B' for Electrical Works will be issued Bidding Documents, and upon payment of non-refundable cost of the documents in the amount of PHP 28,000.00 inclusive of VAT. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids. Interested contractors are required to present a certified copy of their PCAB registration when purchasing the Bidding Documents.

Prospective bidders should possess a valid PCAB license and registration particulars applicable to the type and cost of the contract to be bid, have key personnel and equipment available for the prosecution of the contract as listed above, and must have completed at least one (1) contract that is similar to the contract to be bid, and with the same major categories of work as the contract to be bid, and whose value is at least 50% of the approved budget for the contract to be bid, updated to current prices using the NSO consumer price indices. Prospective bidders must likewise meet the other eligibility, technical/project and financial requirements and other requirements stated in the Eligibility Statement Forms and the Bidding Documents.

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criteria as specified in the 2016 Revised IRR of RA 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least 75% interest or outstanding capital stock belonging to citizens of the Philippines.
