

**Invitation to Bid**  
**Repair of Port Lighting System, Port of Mansalay, Oriental Mindoro**

The Philippine Ports Authority Port Management Office of Mindoro (PPA PMO Mindoro), through the Corporate Budget of the Authority for CY 2019, intends to apply the sum of **Seven Million Four Hundred Ninety Nine Thousand Two Hundred Fifty Two and 43/100 Pesos (Php7,499,252.43)** being the Approved Budget for the Contract (ABC), to payment under the contract for the **Repair of Port Lighting System, Port of Mansalay, Oriental Mindoro**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

PPA PMO Mindoro now invites bids for the supply and installation of 27 sets LED solar streetlight. Completion of the works is required at **One Hundred (100) Calendar Days**. Bidders should have completed a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instruction to Bidders.

The Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the 2016 Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.

The Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from Bids and Awards Committee, PPA PMO Mindoro and inspect the Bidding Documents at the address given below from 8:00 a.m. to 5:00 p.m.

A complete set of Bidding Documents may be acquired by interested Bidders on October 23 to November 11, 2019 from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of Ten Thousand (Php10,000.00) Pesos.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Philippine Ports Authority, provided that the bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

PPA PMO Mindoro will hold a Pre-Bid Conference on October 30, 2019, Wednesday, 9:00 a.m. at PPA PMO Mindoro Conference Room, Port Area, Barangay San Antonio, Calapan City, Oriental Mindoro, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before November 11, 2019, Monday at 9:00 a.m. All bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on November 11, 2019, 9:15 a.m. at PPA PMO Mindoro, Port Area, Barangay San Antonio, Calapan City, Oriental Mindoro. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

Required PCAB Registration: SMALL B – “Port, Harbor and Offshore Engineering”

The Philippine Ports Authority reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
