

**INVITATION TO BID FOR**  
***Proposed Supply, Delivery and Installation of Various  
Fixtures and Furnitures at PMO Mindoro***

Philippine Ports Authority Port Management Office of Mindoro (PPA PMO Mindoro), through the Corporate Budget of the Authority for CY 2021, intends to apply the sum of One Million Eight Hundred Sixty Eight Thousand Pesos (Php1,868,000.00) being the Approved Budget for the Contract (ABC), to payments under the contract for the Proposed Supply, Delivery and Installation of Various Fixtures and Furnitures at PMO Mindoro. Bids received in excess of the ABC shall be automatically rejected at bid opening.

PPA PMO Mindoro now invites bids for the supply, delivery and installation of various fixtures and Furnitures. Delivery of the Goods are required within Sixty (60) days upon receipt of notice to proceed. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

The Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

The Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

Interested bidders may obtain further information from PPA PMO Mindoro and inspect the Bidding Documents at the address given below during 8:00a.m to 5:00p.m.

A complete set of Bidding Documents may be acquired by interested Bidders on November 22 - December 13, 2021 from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of Five Thousand (Php5,000.00) Pesos.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

To reduce the risks and hazards of COVID 19 local transmission the PPA PMO Mindoro BAC will hold a virtual meeting for the Pre-bid Conference with all interested bidders on December 1, 2021, Wednesday, 9:00 a.m., at PPA PMO Mindoro Conference Room, Port Area, Barangay San Antonio, Calapan City, Oriental Mindoro, via <https://tinyurl.com/4k2vffny>.

Bids must be duly received by the BAC Secretariat at the address below on or before December 13, 2021, Monday at 9:00 a.m. All bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount of stated in ITB Clause 18.

Bid opening shall be on December 13, 2021, 9:15 a.m at PPA PMO Mindoro, Port Area, Barangay San Antonio, Calapan City, Oriental Mindoro. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The BAC shall conduct the virtual meeting for the opening of bids on December 13, 2021, 9:15 a.m., via <https://tinyurl.com/fvc4n28f>. Authorized attendees, including representatives of bidders, who are physically present at the PPA PMO Mindoro Conference Room, Port Area, Barangay San Antonio, Calapan City, Oriental Mindoro shall likewise join the meeting via video conferencing.

Philippine Ports Authority Port Management Office of Mindoro reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
