



INVITATION TO BID

UPGRADING OF 3 SETS 100KVA TRANSFORMERS TO 3 SETS 167KVA TRANSFORMERS, BASEPORT LEGAZPI PORT OF LEGAZPI CITY

1. The **Philippine Ports Authority – Port Management Office of Bicol**, through the **PPA** Corporate Budget of the Authority for CY 2021, intends to apply the sum of **One Million Five Hundred Forty-Nine Thousand Eight Hundred Ninety-Two Thousand and Fifty Centavos (P 1,549,892.50)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Upgrading of 3 Sets 100KVA Transformers to 3 Sets 167 KVA Transformers, Baseport Legazpi, Legazpi City**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Philippine Ports Authority- PMO-Bicol now invites bids for the above procurement Project. Completion of the Services is required in Seven **(7) Calendar Days**. Bidders should have completed within (5) years from the date of the submission and receipts of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

List of Equipment Required : Boom Truck

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary **“Pass/Fail”** criterion as also specified in the 2016 Revised IRR of R.A. 9184, otherwise known as the “Government Procurement Reform Act.”


Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Prospective bidders may obtain further information from the Bids and Awards Committee, Philippine Ports Authority, Port Management Office- Bicol for the Bidding Documents at the address given below from **8:00 a. m. to 5:00 p.m.**, Monday to Friday.
5. A complete set of Bidding Documents will be issued to the interested Bidders starting **April 13, 2021** from the address below and upon payment of non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **ONE THOUSAND FIVE HUNDRED PESOS (P 1,500.00)**. The procuring entity shall allow the bidder to present its proof of payment for the fees in person.
6. The Philippine Ports Authority- PMO-Bicol Bids and Awards Committee will hold a Pre-Bid Conference on **April 21, 2021, 2:00 P.M.** at the Conference Room, PMO Administration Building, Regional Government Center, Rawis, Legazpi City, which shall be open to prospective bidders. All Interested parties who will participate in the Pre-bid Conference and Opening of Bid **should possess a proper authorization and company ID**.
7. Bids must be duly received by the BAC Secretariat on or before **9:00 A.M of May 3, 2021** at the Bids and Awards Committee, PMO Administration Building, Regional Government Center, Rawis, Legazpi City. All bids must be accompanied by a Bid Security/Bid Securing Declaration in accordance with Section 27.2 of the Revised IRR of R.A. 9184.

Bid opening shall be on **May 03, 2021, 10:00 A.M** at the Conference Room, PMO Administration Building, Regional Government Center, Rawis, Legazpi City. Bids will be opened in the presence of the Bidder’s representatives who choose to attend at the activity. Late bids shall not be accepted

8. The Philippine Ports Authority reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
