4. Bidding will be conducted through open competitive bidding procedures using non-discretionary "Pass/Fail" criterion as also specified in the 2016 Revised IRR of R.A. 9184, otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

- 5. Interested bidders may obtain further information from the Bids and Awards Committee, Philippine Ports Authority, Port Management Office- Bicol for the Bidding Documents at the address given below from 8:00 a. m. to 5:00 p.m., Monday to Friday.
- 6. A complete set of Bidding Documents will be issued to the interested Bidders starting September 6, 2021 from the address below and upon payment of non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Fifteen Thousand Pesos (P 15,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Philippine Ports Authority, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 7. The Philippine Ports Authority- PMO-Bicol Bids and Awards Committee for Engineering Projects will hold a Pre-Bid Conference on **September 14, 2021, 2:00 P.M**. at the PPA 2<sup>nd</sup> Floor Port Operations Building, Baseport Legazpi City, which shall be open to prospective bidders. All Interested parties who will participate in the Pre-bid Conference and Opening of Bid **should possess a proper authorization and company ID**. Only one representative is allowed for every prospective bidder to attend the pre-bid conference and the opening of bids.
- Bids must be duly received by the BAC Secretariat on or before 9:00 A.M of September 27, 2021 at the Bids and Awards Committee, PMO Administration Building, Regional Government Center, Rawis, Legazpi City. All bids must be accompanied by a Bid Security/Bid Securing Declaration in accordance with Section 27.2 of the Revised IRR of R.A. 9184.

Bid opening shall be on **September 27, 2021, 10:00 A.M** at the Conference Room, PMO Administration Building, Regional Government Center, Rawis, Legazpi City. Bids will be opened in the presence of the Bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.

9. Required PCAB Registration: Small B – General Engineering (Port, Harbor and Offshore Engineering)

Submission of Company Profile is required for new interested bidders whose legal documents are not yet on file with the PMO-Bicol Bids and Awards Committee.
