

INVITATION TO BID

FOR THE:

**REPAIR OF CAUSEWAY, PORT LIGHTING SYSTEM, FENCE AND GATE
PORT OF BULAN, SORSOGON
(CONTRACT NO. BCL 21-17)**

1. The **Philippine Ports Authority – Port Management Office of Bicol**, through the **PPA Corporate Budget of the Authority for CY 2021**, intends to apply the sum of **Twenty-Nine Million Nine Hundred Sixty-Seven Thousand Two Hundred Fifteen Pesos and Thirteen Centavos (P 29,967,215.13)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Repair of Causeway, Port Lighting System, Fence and Gate, Port of Bulan, Sorsogon**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Philippine Ports Authority- PMO-Bicol now invites bids for the following Scope of Works:

Completion of the Works is required in **Three Hundred (300) Calendar Days**. Bidders should have completed a contract similar to the major items of the project such as Item No. 3 & 4. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Equipment Required: 1 unit - Jackhammer with Compressor; 1 unit - Dump Truck (8 cu.m capacity) ; 1 unit - Backhoe (0.40cu.m 94.30hp); 1 unit - Truck Mounted Crane 35T; ; 1 Unit - Bar Cutter; 1 unit - Bar Bender; 1 unit - 1 Bagger Concrete Mixer; 1 unit - Concrete Vibrator 3.5hp ; 1 unit Concrete Cutter; 1 unit - Water truck with Pump; 1 unit Road Roller; 1 unit - Clamshell, Bucket or Cable ; 1 unit – Oxy/Acetylene Cutting Outfit; 1 unit Welding Machine with Generator Set; 1 unit Boom Truck (2.5T capacity); 1 unit – Concrete Screeder; 1 unit – Portable Grinder; 1 unit Road Grader (125hp)
4. Bidding will be conducted through open competitive bidding procedures using non-discretionary **“Pass/Fail”** criterion as also specified in the 2016 Revised IRR of R.A. 9184, otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

5. Interested bidders may obtain further information from the Bids and Awards Committee, Philippine Ports Authority, Port Management Office- Bicol for the Bidding Documents at the address given below from **8:00 a. m. to 5:00 p.m.**, Monday to Friday.

6. A complete set of Bidding Documents will be issued to the interested Bidders starting **October 25 – November 12, 2021** from the address below and upon presentation of payment of non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Twenty Five Thousand Pesos (P 25,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Philippine Ports Authority, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

7. The Philippine Ports Authority- PMO-Bicol Bids and Awards Committee for Engineering Projects will hold a Pre-Bid Conference on **November 2, 2021, 2:00 P.M.** at the PPA, 2nd Floor, Passenger Terminal Building, Baseport Legazpi City, which shall be open to prospective bidders. All Interested parties who will participate in the Pre-bid Conference and Opening of Bids **should possess a proper authorization and company ID**. Only one representative is allowed for every prospective bidder to attend the pre-bid conference and the opening of bids..
8. Bids must be duly received by the BAC Secretariat on or before **1:00 P.M of November 15, 2021** at the Bids and Awards Committee, PPA, 2nd Floor Passenger Terminal Building, Baseport Legazpi City. All bids must be accompanied by a Bid Security/Bid Securing Declaration in accordance with Section 27.2 of the Revised IRR of R.A. 9184.


Bid opening shall be on **November 15, 2021, 2:00 P.M** at the Conference Room, PMO Administration Building, Regional Government Center, Rawis, Legazpi City. Bids will be opened in the presence of the Bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.

9. Required PCAB Registration: Small B – General Engineering (Port, Harbor and Offshore Engineering)

Submission of Company Profile is required for new interested bidders whose legal documents are not yet on file with the PMO-Bicol Bids and Awards Committee.

The Philippine Ports Authority reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
