INVITATION TO BID

FOR THE VARIOUS MAINTENANCE OF PORT PHYSICAL FACILITIES, PORT OF PUERTO PRINCESA, PALAWAN

The Philippine Ports Authority - PMO Palawan, through the Corporate Budget of the Authority for CY 2017, intends to apply the sum ₱ **2,747,915.62** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Various Maintenance of Port Physical Facilities, Port of Puerto Princesa, Palawan (MPF-PLW-02-2017)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Philippine Ports Authority –PMO Palawan now invites bids for the following Scope of Works:

1. Maintenance of Ticketing Booth at Main Entrance Gate
2. Maintenance of Covered Vehicle Parking Shed-1
3. Maintenance of Covered Vehicle Parking Shed-2
4. Maintenance of Pump House Area
5. Maintenance of R.C. Canal Along Port Road (Commercial Area) & at the Operational Area
6. Maintenance of Steel Matting Fence Fronting Main Entrance Gate
7. Maintenance of Damaged CHB and Steel Perimeter Fence at Left Wing
8. Repair of Concrete Ramp and Handrailings for PWD at P.A.S.S. Building
9. Maintenance of Port Lighting Fixtures (Relocation of the Existing Three (3) Units)
10. Re-installation of Mooring Cleats
11. Maintenance of Perimeter Fence Along Arastre Ticketing Booth

Completion of the Works is required in **One Hundred Fifty (150) calendar days**. Bidders must have completed a Single Largest Completed Contract (SLCC) that is similar to the contract to be bid, and whose value, adjusted to current prices using the PSA consumer price indices, must be at least fifty (50%) of the ABC to be bid. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.

The Equipment Requirement, (Owned/Leased and/or Under Purchase Agreement), for this project are:

- 1 unit – Welding Genset, 400Amp
- 1 unit – Electric Cut-off Machine
- 1 unit – Electric Compressor with Spray Gun
- 1 unit – Elf Truck, 3.0. cu.m. capacity
- 1 unit – Electric Jack Hammer
- 1 unit – Concrete Cutter, 5HP
- 1 unit – Concrete Mixer, 1-Bagger
- 1 unit – Concrete Vibrator, 5HP
- 1 unit – Oxy-Acetylene Cutting Outfit
- 1 unit – Migweld Welding Machine (w/Chemical Argon)
- 1 unit – Boom Truck, 6T

Bidding will be conducted through open competitive bidding procedures using non-discretionary **“pass/fail”** criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A. 9184)., otherwise known as the “Government Procurement Reform Act.”

VISION

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the Bids and Awards Committee (BAC) for Engineering Projects, Philippine Ports Authority, Port Management Office- Palawan and inspect the Bidding Documents at the address given below from **8:00 a. m. to 5:00 p.m., Monday to Friday.**

A complete set of Bidding Documents may be acquired by interested Bidders on **February 01-21, 2017** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **FIVE THOUSAND PESOS (P5,000.00).**

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and at the website of the Philippine Ports Authority, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

The Bids and Awards Committee (BAC) for Engineering Projects, Philippine Ports Authority, Port Management Office- Palawan will hold a Pre-Bid Conference on **February 8, 2017, 9:30 AM** at 3rd Floor, Social Hall, PPA Administrative Building, Port of Area, Puerto Princesa City, which shall be open to all interested bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before **8:30 a.m. of February 21, 2017.** All bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The Philippine Ports Authority PMO-Palawan reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
