



**INVITATION FOR SUBMISSION OF QUOTATION
(SMALL VALUE PROCUREMENT)**

The Philippine Ports Authority, Port Management Office of Bohol through its Bids and Awards Committee (BAC), invites interested contractors/bidders for the herein project: **“REPAIR/REINSTALLATION OF RUBBER DOCK FENDERS TO INCLUDE CORING AND APPLICATION OF CONCRETE EPOXY AT PORT OF GETAFE. PORT OF GETAFE, GETAFE, BOHOL”**

Approved Budget for the Contract (ABC) : Php 176,578.47

Scope of Work :

1. Supply of stainless steel anchor bolts, coring, and installation of Rubber Dock Fenders to include hauling of 2 units Rubber Dock Fender from Port of Loon to Port of Getafe

Prospective bidders shall submit their quotations, together with the Certified True Copies of the following documents in three (3) sets, one (1) original and two (2) duplicate copies:

1. Valid Mayor's Business Permit ;
2. PhilGEPS Registration Number;
3. Omnibus Sworn Statement;
4. Income/Business Tax Return; and
5. PCAB License (Small B).

A complete set of documents may be purchased by interested bidders from the address given below and upon payment of a **non-refundable** fee for the bidding documents in the amount of **FIVE HUNDRED PESOS ONLY (Php 500.00)** as per PPA Memorandum Circular No. 10-2012 dated September 19, 2012.

Procurement will be conducted in consonance with Section 53.9 of the 2016 Revised Implementing Rules and Regulations of Republic Act 9184 (R.A. 9184), otherwise known as the “Government Procurement Reform Act”. Only sealed quotations/canvass from eligible bidders will be opened and contract will only be awarded to the **Lowest Calculated and Responsive Bidder** who will be determined during the conduct of the post-qualification.

Quotations must be submitted to the address given below, on or before **10:00 AM of Wednesday, May 24, 2023** to the Secretariat, Bids and Awards Committee (BAC). Said quotations will be opened on the same day at **10:30 AM**.






