



## INVITATION TO BID

### REPAIR/REBLOCKING OF DAMAGED CONCRETE PAVEMENT AT THE PORTS OF TUBIGON AND GETAFE, TUBIGON AND GETAFE, BOHOL

The Philippine Ports Authority, through the Corporate Budget of the Authority for CY 2021, intends to apply the sum of Pesos: **Twenty Two Million Eight Hundred Thirty Thousand One Hundred Ninety Seven Pesos and Nineteen Centavos (P22,830,197.19)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Repair/Reblocking of Damaged Concrete Pavement at the Ports of Tubigon and Getafe, Tubigon and Getafe, Bohol**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Philippine Ports Authority now invites bids for the following scope of work :

- 1.0 General Expenses
- 2.0 Repair of damaged concrete pavement and RoRo ramp on fill.
- 3.0 Repair of drainage system

Completion of the Works is required in **180 calendar days**. Bidders should have completed, **within ten (10) years from the date of submission and receipt of bids, a single largest contract completed similar to the Project**. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through **open competitive bidding** procedures using **non-discretionary pass/fail criterion** as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the Bids and Awards Committee and inspect the Bidding Documents at the address given below from 8:00 A.M. to 5:00 P.M.

A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a **non-refundable** fee of **TWENTY FIVE THOUSAND PESOS (P 25,000.00)** per PPA Memorandum Circular No. 10-2012 dated September 19, 2012.

The Bids and Awards Committee will hold a Pre-Bid Conference on **30 September 2021 at 02:00 PM** at the Multi-Purpose Hall, PPA PMO-Bohol Administration Building, Port Area, Tagbilaran City, which shall be open to all interested parties who have purchased the Bidding Documents.

Bids must be delivered to the address below **on or before 10:00 A.M. of 12 October 2021** at the Bids and Awards Committee (BAC), Engineering Services Division, PPA PMO-Bohol PMO Administration Building, Port Area, Tagbilaran City. All bids **must be accompanied by a Notarized Bid Securing Declaration or any of the Bid Security** in the following acceptable forms and amount:
