

INVITATION TO BID

REPAIR/REPLACEMENT OF SETTLED CONCRETE PAVING BLOCKS INTO PORTLAND CEMENT CONCRETE PAVEMENT TO INCLUDE PORT LIGHTING SYSTEM, PORT OF UBAY, UBAY, BOHOL

The Philippine Ports Authority, through the Corporate Budget of the Authority for CY 2021, intends to apply the sum of Pesos: Nineteen Million Nine Hundred Sixteen Thousand One Hundred Sixty One Pesos and Twenty Eight Centavos (P19,916,161.28) being the Approved Budget for the Contract (ABC) to payments under the contract for the Repair/Replacement of Settled Concrete Paving Blocks into Portland Cement Concrete Pavement to Include Port Lighting System, Port of Ubay, Ubay, Bohol. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Philippine Ports Authority now invites bids for the following scope of work:

- 1.0 General Expenses
- 2.0 Demolition, Removal, Extraction and Excavation Works
- 3.0 Portland Cement Concrete Pavement

Completion of the Works is required in **240 calendar days.** Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a single largest contract completed similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through **open competitive bidding** procedures using **non-discretionary pass/fail criterion** as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the Bids and Awards Committee and inspect the Bidding Documents at the address given below from 8:00 A.M. to 5:00 P.M.

A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a **non-refundable** fee of **TWENTY FIVE THOUSAND PESOS** (**25,000.00**) per PPA Memorandum Circular No. 10-2012 dated September 19, 2012.

The Bids and Awards Committee will hold a Pre-Bid Conference on <u>30 September 2021 at 02:00</u> <u>PM</u> at the Multi-Purpose Hall, PPA PMO-Bohol Administration Building, Port Area, Tagbilaran City, which shall be open to all interested parties who have purchased the Bidding Documents.

Bids must be delivered to the address below on or before 10:00 A.M. of 12 October 2021 at the Bids and Awards Committee (BAC), Engineering Services Division, PPA PMO-Bohol PMO Administration Building, Port Area, Tagbilaran City. All bids must be accompanied by a Notarized Bid Securing Declaration or any of the Bid Security in the following acceptable forms and amount:

 a) Cash, cashier's/ manager's check issued by a Universal or Commercial Bank Two percent (2%)

b) Bank draft/guarantee or Irrevocable letter of credit issued by a Universal or Commercial Bank: Provided, however that it shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank.

Two percent (2%)

c) Surety Bond callable upon demand Issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security

Five percent (5%)

d) Any combination of the foregoing

Proportionate to share of form with respect to total amount of security

Bids will be opened in the presence of the bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.
