



## INVITATION TO BID

### REPAIR OF CAVED-IN/SETTLED BACK-UP AREA PORT OF LOON, CATAGBACAN, LOON, BOHOL

The Philippine Ports Authority, through the Corporate Budget of the Authority for CY 2019, intends to apply the sum of Pesos: **Four Million Nine Hundred Thirty Eight Thousand Three Hundred One Pesos and 53/100 ( ₱ 4,938,301.53)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Repair of Caved-in/Settled Back-up Area Port of Loon, Catagbacan, Loon, Bohol (A190144)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Philippine Ports Authority now invites bids for the following scope of work :

- A. Mobilization/Demobilization**
- B. Repair of Caved-in/Settled Back-up Area**
- C. Repair of Mooring System**

Completion of the Works is required in **90 calendar days**. Bidders should have completed, **within ten (10) years from the date of submission and receipt of bids, a single largest contract completed similar to the Project**. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through **open competitive bidding** procedures using **non-discretionary pass/fail criterion** as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the Bids and Awards Committee and inspect the Bidding Documents at the address given below from 8:00 A.M. to 5:00 P.M.

A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a **non-refundable** fee of **FIVE THOUSAND PESOS (₱ 5,000.00)** per PPA Memorandum Circular No. 10-2012 dated September 19, 2012.

The Bids and Awards Committee will hold a Pre-Bid Conference on **21 October 2019 at 2:00 P.M.** at the Multi-Purpose Hall, PMO Administration Building, PPA Bohol, Port Area, Tagbilaran City, which shall be open to all interested parties who have purchased the Bidding Documents.

Bids must be delivered to the address below **on or before 10:00 A.M. of 05 November 2019** at the Bids and Awards Committee (BAC), Office of the Port Manager, PMO Administration Building, PPA Bohol, Port Area, Tagbilaran City. All bids **must be accompanied by a Notarized Bid Securing Declaration or any of the Bid Security** in the following acceptable forms and amount:


