

INVITATION TO BID

SUPPLY AND DELIVERY OF ADDITIONAL HIGH AMPERAGE CABLES INTENDED FOR EIGHT (8) UNITS GENERATOR SETS WITH AUTOMATIC TRANSFER SWITCH (ATS) FOR PMO-BOHOL

The Philippine Ports Authority, through the Corporate Budget of the Authority for CY 2019, intends to apply the sum of Pesos: Four Million Four Hundred Forty Nine Thousand Four Hundred Fifty Pesos Only (P4,449,450.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply and Delivery of Additional High Amperage Cables Intended for Eight (8) Units Generator Sets with Automatic Transfer Switch (ATS) for PMO-Bohol. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Philippine Ports Authority now invites bids for the following specifications:

1.01 Supply and Delivery of 954 l.m. - 240mm² High Amperage (Double Shielded) Wire for Tagbilaran, Tubigon and Jagna Ports

Breakdown: Tagbilaran = 116.00 l.m. Tubigon = 611.00 l.m. Jagna = 227.00 l.m.

1.02 Supply and Delivery of 1,801.71 l.m. - 95mm² High Amperage (Double Shielded) Wire for Loon, Getafe, Talibon, Ubay and Tapal Ports

Breakdown: Loon = 839.71 l.m. Getafe = 392.00 l.m. Talibon = 182.00 l.m.

Ubay = 275.00 l.m. Tapal = 113.00 l.m.

Delivery of the Goods is required in 45 calendar days. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a single largest contract completed similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through **open competitive bidding** procedures using **non-discretionary pass/fail criterion** as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the Bids and Awards Committee and inspect the Bidding Documents at the address given below from 8:00 A.M. to 5:00 P.M.

A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a **non-refundable** fee of **FIVE THOUSAND PESOS** (**2** 5,000.00) per PPA Memorandum Circular No. 10-2012 dated September 19, 2012.

The Bids and Awards Committee will hold a Pre-Bid Conference on **02 December 2019 at 2:00 PM** at the Multi-Purpose Hall, PMO Administration Building, PPA Bohol, Port Area, Tagbilaran City, which shall be open to all interested parties.



Bids must be delivered to the address below **on or before 10:00 AM of 16 December 2019** at the Bids and Awards Committee (BAC), Office of the Port Manager, PMO Administration Building, PPA Bohol, Port Area, Tagbilaran City. Said bids will be opened on the same day at **10:30 AM**.

All bids must be accompanied by a Notarized Bid Securing Declaration or any of the Bid Security in the following acceptable forms and amount:

 a) Cash, cashier's/ manager's check issued by a Universal or Commercial Bank

Two percent (2%)

b) Bank draft/guarantee or Irrevocable letter of credit issued by a Universal or Commercial Bank: Provided, however that it shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank.

Two percent (2%)

 c) Surety Bond callable upon demand Issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security.

Five percent (5%)

Bids will be opened in the presence of the bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.

The Philippine Ports Authority reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
