INVITATION TO BID

PPA, PMO-BOHOL FOR CY 2017

 The PHILIPPINE PORTS AUTHORITY, PORT MANAGEMENT OFFICE OF BOHOL, through the PPA Corporate Funds intends to apply the sum of EIGHT MILLION FOUR HUNDRED NINETY SEVEN THOUSAND EIGHT HUNDRED SIXTY-FOUR PESOS AND 06/100 (Php8,497,864.06), being the Approved Budget for the Contract (ABC) to cover payments under the Contract for the Provision of Administrative and Technical Support Manpower Services for CY 2017.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 2. The PPA, PMO-BOHOL now invites Manpower Service Providers/Contractors to bid for the Provision of forty-four (44 Administrative and Technical Support Manpower Personnel for PMO-Bohol. The contract shall be effective for a period of ten (10) months (starting March 1, 2017 to December 31, 2017) for PMO-Bohol. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a single contract that is similar to the Project with an amount equivalent to at least fifty percent (50%) of the ABC. The technical description of an eligible bidder is contained in the Bidding Documents, particularly in Section II, Instructions to Bidders.
- Bidding will be conducted through open and competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act (RA) 5183 and subject to Commonwealth Act 138.
- Interested Bidders may obtain further information from the PHILIPPINE PORTS
 AUTHORITY, PORT MANAGEMENT OFFICE OF BOHOL, Bids and Awards Committee for
 Procurement of Goods, through the Secretariat; and inspect the Bidding Documents at the
