

## Invitation to Bid for

### ***“Repair of Damaged Pavement and Replacement of Damaged Rubber Dock Fenders at Port of Dumaguít, New Washington, Aklan”***

1. The Philippine Ports Authority, PMO-Panay/Guimaras, through the PPA Corporate Fund (R/M 2019) intends to apply the sum of ***Fifteen Million One Hundred Sixty-Eight Thousand Five Hundred Seventy-Seven Pesos and 10/100 (P 15,168,577.10)*** being the Approved Budget for the Contract (ABC) to payments under the contract for ***“Repair of Damaged Pavement and Replacement of Damaged Rubber Dock Fender sat Port of Dumaguít, New Washington, Aklan”***. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Philippine Ports Authority, PMO-Panay/Guimaras now invites bids for:

- *Mobilization/Demolition*
- *General Expenses*
- *Safety, Health and Environment Management Program*
- *Repair of Damaged Pavement*
- *Supply and Replace Damaged RDF*

2. Completion of the Works is required ***120 Calendar Days*** from the effective date of the contract. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from Engineering Services Division, Philippine Ports Authority, PMO-Panay/Guimaras and inspect the Bidding Documents at the address given below from 8:30am to 5:00pm.

5. A complete set of Bidding Documents may be acquired by interested bidders starting September 9, 2019 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty Five Thousand Pesos (P25, 000.00) VAT Exclusive.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Philippine Ports Authority, PMO-Panay/Guimaras will hold a Pre-Bid Conference on ***October 7, 2019, 10:00 A.M (PPA Time)*** at the ***Conference Room, 2nd Floor, Admin. Bldg., ICPC, Iloilo City*** which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before ***October 21, 2019 at 8:30 A.M(PPA Time)*** at the Conference Room, 2nd Floor, Admin. Bldg., ICPC, Iloilo City. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
