



The *Philippine Ports Authority, PMO-Panay/Guimaras*, through the *PPA Corporate Fund* intends to apply the sum of ***Twenty-Nine Million, Three Hundred Eighty-Three Thousand, Seven Hundred Ninety-Nine Pesos and 26/100 (P 29,383,799.26)*** being the Approved Budget for the Contract (ABC) to payments under the contract for ***“Repair/Replacement of Damaged Fendering System at Muelle Loney Side of Iloilo River Wharf, Port of Iloilo, Iloilo City (Sta.0+481.903 to Sta.1+301.828, covering 820 L.m. of wharf)” (A190151)”*** Bids received in excess of the ABC shall be automatically rejected at bid opening.

- Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
