

## **Invitation to Bid for**

## "Repair of Damaged & Deteriorated RC Deck at Fort San Pedro, Iloilo City"

1. The Philippine Ports Authority, PMO-Panay/Guimaras, through the PPA Corporate Fund intends to apply the sum of Twenty-Nine Million Seven Hundred Eighty-Three Thousand Two Hundred Eighty-Two Pesos and 67/100 (P 29,783,282.67) being the Approved Budget for the Contract (ABC) to payments under the contract for "Repair of Damaged & Deteriorated RC Deck at Fort San Pedro, Iloilo City" (A190172). Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Philippine Ports Authority, PMO-Panay/Guimaras now invites bids for

- 1.0 Mobilization/Demobilization
- 2.0 General Expenses
- 2.01 General Expenses includes pre-con survey and provision of temp. facilities
- 2.02 Construction Safety and Health Program
- 3.0 Demolition Works
- 3.01 Demolition/removal of deteriorated RC Deck and RC Beams
- 3.02 Chipping/demolish existing RC Piles to designated elevation as detailed in the plan
- 4.0 Reinforced Concrete Works
- 4.10 Supply and Place 3,500 psi for RC Deck and RC Beam
- 4.20 Supply and Install reinforcement for Item 4.10, Grade 40, fý=276Mpa
- Completion of the Works is required 375 Calendar Days from the effective date of the contract. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II.Instruction to Bidders.
- Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."
  - Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 4. Interested bidders may obtain further information from Engineering Services Division, Philippine Ports Authority, PMO-Panay/Guimaras and inspect the Bidding Documents at the address given below from 8:00am to 5:00pm.
- 5. A complete set of Bidding Documents may be acquired by interested bidders starting November 29, 2019, 8:30 A.M to 4:30 P.M from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty-Five Thousand Pesos (P25, 000.00) VAT Exclusive.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6. The Philippine Ports Authority (PPA), Port Management Office-Panay/Guimaras will hold a Pre-Bid Conference on *December 6, 2019 2:00 P.M. (PPA time)* at the *PPA Engineering Services Division Office, 4th floor, Administration Building, Iloilo Commercial Port Complex (ICPC), Brgy. Loboc, La Paz*, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat at the address below on or before December 19, 2019 at 1:30 P.M at the PPA Conference Room, 2nd floor, Administration Building, Iloilo Commercial Port Complex (ICPC), Brgy. Loboc, La Paz. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on *December 19, 2019 at 2:00 P.M.* at the *PPA Conference Room, 2nd floor, Administration Building, Iloilo Commercial Port Complex (ICPC), Brgy. Loboc, La Paz.* Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
