### **INVITATION TO BID**

# REPAIR OF PORT SAFETY AND SECURITY FACILITIES, PORT OF ORMOC, CITY

The Philippine Ports Authority, Port Management Office – Western Leyte/Biliran, through the Corporate Budget of the Authority for CY 2021, intends to apply the sum of P 34,376,798.00 being the Approved Budget for the Contract (ABC) to payments under the contract for the project – *Repair of Port Safety and Security Facilities, Port of Ormoc, City (NRP-WLB-01-21)*. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Philippine Ports Authority, Port Management Office – Western Leyte/Biliran now invites bids for the *Repair of Port Safety and Security Facilities, Port of Ormoc, City (NRP-WLB-01-21).* Completion of Works required for the project is *Three Hundred (300) Calendar Days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using nondiscretionary pass/fail criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives and partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from *Philippine Ports Authority, Port Management Office – Western Leyte/Biliran* and inspect the Bidding Documents at the address given below from 8:00am – 5:00pm.

A complete set of Bidding Documents may be acquired by interested Bidders on **September 15, 2021** from the address below and upon payment of the applicable fee for the Bidding Documents pursuant to the latest Guidelines issued by GPPB, in the amount of **P 25,000.00**.

It may also be downloadable free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of Philippine Ports Authority, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

The Philippine Ports Authority, Port Management Office – Western Leyte/Biliran will hold a Pre-Bid Conference on **September 23, 2021, 10:00 A.M** at Philippine Ports Authority, Port Management Office – Western Leyte/Biliran, Port Operation Building,

Conference Room, Ebony St., Port Area., Ormoc City, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before **October 6, 2021, 10:00 A.M**. All bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on **October 6, 2021, 10:30 A.M** at *Philippine Ports Authority, Port Management Office – Western Leyte/Biliran, Port Operation Building, Conference Room, Ebony St. Port Area, Ormoc City.* Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
