The *Philippine Ports Authority*, through the Corporate Budget of the Authority for CY 2016 intends to apply the sum of **One Million Nine Hundred Seven Thousand Eight Hundred Eight Pesos Only (Php 1,907,808.00)** being the **Approved Budget for the Contract (ABC)** to payments under the contract Invitation to Bid for the **Supply, Delivery and Assembly of 224 sets Brand New Heavy Duty, 4-seaters Chrome Coated Steel Gang Chairs to the Ports of Ormoc, Maasin, Hilongos, Baybay, Palompon, and Naval**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The *Philippine Ports Authority Port Management Office – Western Leyte/Biliran (PPA PMO-WLB)* now invites bids for the **Supply, Delivery and Assembly of 224 sets Brand New Heavy Duty, 4-seaters Chrome Coated Steel Gang Chairs to the Ports of Ormoc, Maasin, Hilongos, Baybay, Palompon, and Naval**. Delivery of the Goods is required *within 30 calendar days upon receipt of Notice to Proceed*. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested bidders may obtain further information from *PPA PMO- WLB* and inspect the Bidding Documents at the address given below during *Mondays to Fridays 08:00AM to 05:00PM*.

A complete set of Bidding Documents may be purchased by interested Bidders starting *December 27, 2016* from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Five Thousand Six Hundred Pesos (Php 5,600.00)** inclusive of 12% VAT.

Veloso St., Ormoc City, which shall be open only to all interested parties who have purchased the Bidding Documents.

Bids must be delivered to the address below on or before **02:30PM of January 16, 2017**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on **January 16, 2017 at 03:00PM** at PPA PMO-WLB, Lot 2, Block 13, Doña Feliza Mejia Subd., D. Veloso St., Ormoc City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The Philippine Ports Authority reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
