### **INVITATION TO BID**

## REPAIR OF RC PIER UNDERDECK, PHASE 1 PORT OF MAASIN, MAASIN CITY, SOUTHERN LEYTE

The Philippine Ports Authority, Port Management Office – Western Leyte/Biliran, through the Corporate Budget of the Authority for CY 2021, intends to apply the sum of P 29,804,880.00 being the Approved Budget for the Contract (ABC) to payment under the contract for the project – Repair of RC Pier Underdeck, Phase 1, Port of Maasin, Maasin City, Southern Leyte (NRP-WLB-06-21). Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Philippine Ports Authority, Port Management Office – Western Leyte/Biliran now invites bids for the *Repair of RC Pier Underdeck, Phase 1, Port of Maasin, Maasin City, Southern Leyte (NRP-WLB-06-21).* Completion of Works required for the project is *One Hundred Eighty (180) Calendar Days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives and partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from *Philippine Ports Authority, Port Management Office – Western Leyte/Biliran* and inspect the Bidding Documents at the address given below from 8:00am – 5:00pm.

A complete set of Bidding Documents may be acquired by interested Bidders on **December 23, 2021** from the address below and upon payment of the applicable fee for the Bidding Documents pursuant to the latest Guidelines issued by GPPB, in the amount of **P 25,000.00**.
