The Philippine Ports Authority, Port Management Office of Lanao del Norte/ Iligan, through its Bids and Awards Committee (BAC) for Engineering Projects, invites contractors registered with and classified by the Philippine Contractors Accreditation Board (PCAB) to bid for the hereunder contract:

- A. Name of Contract : Proposed Repair of Pavement of Back-up Area,

D. Brief Description : This project entails the chipping, disposal and hauling of damaged concrete pavement and unsuitable materials, backfilling and compaction of sub base and base course, supply, deliver and install reinforcement bars, supply, deliver and pouring of 5,000 psi concrete

G. Source of Fund : PPA Corporate Fund
H. Contract Duration : 150 calendar days
I. Required PCAB Registration : Medium A, Road, Highway pavement, Railways, Airport horizontal, Structures and Bridges (Minimum)

Only those contractors with the certified copy of PCAB license/registration will be issued Bidding Documents. For purposes of verification, please present original copy of PCAB license and proof of experience. A complete set of Bidding Documents may be purchased by interested Bidders from the address below upon payment of a non-refundable fee of **Twenty Five Thousand Pesos (P 25,000.00)**.

Prospective bidders should possess a valid PCAB License and registration particulars applicable to the type and cost of the contract to be bid, have key personnel and equipment available for the prosecution of the contract as listed in Item E above, and must have completed a contract similar to the contract to be bid and with the same major categories of work as the contract to be bid with a value of at least 50% of the approved budget for the contract to be bid, updated to current prices using the NSO price indices, and must meet the other eligibility, technical/project, and financial requirements and other requirements stated in the Eligibility Statement Form and the Bidding Documents.

Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criteria as specified in the IRR of RA 9184, otherwise known as the “Government

Procurement Reform Act". This Office is not electronically-ready to handle electronically submitted bid/proposals as of this date.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships or organizations with at least 75% interest or outstanding capital stock belonging to citizens of the Philippines.
