D. Brief Description : This project entails the chipping and disposal of pavement affected

by the drainage system, excavation/ cleaning of the drainage, installation of reinforcement for drainage canal, pouring of concrete drainage flooring, sides and pavement, chipping-off concrete portion of existing column and pavement to include disposal of unnecessary debris as per instructed. Excavation of existing fill materials to include backfilling and compaction for foundations. Installation of reinforcing bars and pouring 3,500 psi concrete for footings columns and etc. Installation of roof framing accessories including roof panels. Supply and install electrical lightings and wirings, including tapping to existing power connection. Application of 1-coat primer and final 2-coats on all steel and masonry surfaces.

For purposes of verification, please present original copy of PCAB license and proof of experience. A complete set of Bidding Documents may be purchased by interested Bidders from the address below upon payment of a non-refundable fee of **Twenty Five Thousand Pesos** (P 25,000.00).

Prospective bidders should possess a valid PCAB License and registration particulars applicable to the type and cost of the contract to be bid, have key personnel and equipment available for the prosecution of the contract as listed in Item E above, and must have completed a contract similar to the contract to be bid and with the same major categories of work as the contract to be bid with a value of at least 50% of the approved budget for the contract to be bid, updated to current prices

using the NSO price indices, and must meet the other eligibility, technical/project, and financial requirements and other requirements stated in the Eligibility Statement Form and the Bidding Documents.

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criteria as specified in the IRR of RA 9184, otherwise known as the "Government Procurement Reform Act". This Office is <u>not electronically-ready</u> to handle electronically submitted bid/proposals as of this date.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships or organizations with at least 75% interest or outstanding capital stock belonging to citizens of the Philippines.
