INVITATION TO BID

The Philippine Ports Authority, Port Management Office of Lanao del Norte/ Iligan, through its Bids and Awards Committee (BAC), invites contractors registered with and classified by the Philippine Contractors Accreditation Board (PCAB) to bid for the hereunder contract:

- A. Name of Contract : Repair of Damaged Rock Bulk Head at the Back-up Area,
- B. Project Code : NRP-LDI-02-21
- C. Location : Port of Kolambugan, Lanao del Norte
- D. Brief Description :

The project involves in demolition, chipping and disposal of affected concrete pavement and supply and spread base and sub-base course to include compaction. Supply and install formworks and supply, fabricate and install reinforcement and pouring. Retrieval and alignment rockbulhead. Supply, install and realignment of rockbulkhead and pouring rubble concrete. Provision of environmental, safety and health program shall be included in the execution of the project.

Only those contractors with the certified copy of PCAB license/registration will be issued Bidding Documents. For purposes of verification, please present original copy of PCAB license and proof of experience. A complete set of Bidding Documents may be acquired by interested Bidders from the address below upon payment of a non-refundable fee of **Twenty-Five Thousand Pesos (P 25,000.00)**.

Prospective bidders should possess a valid PCAB License and registration particulars applicable to the type and cost of the contract to be bid, have key personnel and equipment available for the prosecution of the contract as listed in Item E above, and must have completed a contract similar to the contract to be bid and with the same major categories of work as the contract to be bid with a value of at least 50% of the approved budget for the contract to be bid, updated to current prices using the NSO price indices, and must meet the other eligibility, technical/project, and financial requirements and other requirements stated in the Eligibility Statement Form and the Bidding Documents.

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criteria as specified in the IRR of RA 9184, otherwise known as the "Government Procurement Reform Act". This Office is not electronically ready to handle electronically submitted bid/proposals as of this date.

Bidding is restricted to Filipino citizens/sole proprietorship, partnerships or organizations with at least 60% interest or outstanding capital stock belonging to citizens of the Philippines.
