**INVITATION TO BID**

The Philippine Ports Authority, Port Management Office of Lanao del Norte/ Iligan, through its Bids and Awards Committee (BAC), invites contractors registered with and classified by the Philippine Contractors Accreditation Board (PCAB) to bid for the hereunder contract:

- A. Name of Contract : Repair of Perimeter Fence Along Gate 2 and Entrance Gate,
- B. Project Code : NRP-LDI-01-21
- C. Location : Port of Iligan, Iligan City
- D. Brief Description :

The project involves in supply and place additional 500kg rock bulkhead, geotextile cloth, backfilling and compaction works to include installation of concrete paving blocks as plan and specification. Installation of reinforcing bars and pouring 3,500 psi concrete on footing, column, pedestal, cable trench & etc.. Fabrication and installation of vehicle gate, roof framing and roof panels and accessories. Installation of 6" concrete hollow blocks with reinforcement and plastering. Supply, deliver and install lighting posts, electronic boom and accessories. Application of 1-coat primer and final 2-coats on all steel and masonry surfaces. Provision of environmental, safety and health program shall be included in the execution of the project.

- I. Required PCAB Registration : Small B, Ports, Harbor and Offshore Engineering (Minimum)

Only those contractors with the certified copy of PCAB license/registration will be issued Bidding Documents. For purposes of verification, please present original copy of PCAB license and proof of experience. A complete set of Bidding Documents may be acquired by interested Bidders from the address below upon payment of a non-refundable fee of **Twenty-Five Thousand Pesos (P 25,000.00)**.

Prospective bidders should possess a valid PCAB License and registration particulars applicable to the type and cost of the contract to be bid, have key personnel and equipment available for the prosecution of the contract as listed in Item E above, and must have completed a contract similar to the contract to be bid and with the same major categories of work as the contract to be bid with a value of at least 50% of the approved budget for the contract to be bid, updated to current prices using the NSO price indices, and must meet the other eligibility, technical/project, and financial

requirements and other requirements stated in the Eligibility Statement Form and the Bidding Documents.

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criteria as specified in the IRR of RA 9184, otherwise known as the "Government Procurement Reform Act". This Office is not electronically ready to handle electronically submitted bid/proposals as of this date.

Bidding is restricted to Filipino citizens/sole proprietorship, partnerships or organizations with at least 60% interest or outstanding capital stock belonging to citizens of the Philippines.
