Bidders should have completed, within the last three (3) years from the date of submission and receipt of bids, a single largest completed contract (SLCC) similar to the Project to be bid and having a value of at least 50% of the approved budget for the contract to be bid, adjusted to current prices using the PSA consumer price indices and supported with corresponding certificate of completion/acceptance from project owner/agency.

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criteria as specified in the Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to duly licensed Filipino citizens/sole proprietorships, partnerships, corporations or cooperatives duly organized under the law of the Philippines and of which at least 75% of the interest or of the outstanding capital stock belongs to citizens of the Philippines.

Interested bidders are required to submit to the BAC Secretariat of PPA, PMO Agusan a Letter of Intent together with the set of machine copies with original for presentation and authentication before the issuance of Bid Documents of the following:

- a) Valid PCAB License/Classification;
- b) Certificate of Completion/Acceptance of owner of the Single Largest Completed Contract within the last three (3) years similar to the project to be bid; and
- c) Certification of non-inclusion in the Consolidated Blacklisting Report issued by the GPPB.

A complete set of Bidding Documents will be available to interested Bidders from the address below upon payment of the specified non-refundable Cost of Bid Documents, **exclusive of 12% VAT.**

This Office is not electronically-ready to handle documents thus submission of bids / proposals electronically is not allowed.
