**Invitation to Bid for  
Emergency Repair of Rock Embankment and Restoration  
of Affected Structure at Port of Masao**


1. The *Philippine Ports Authority – Port Management Office of Agusan*, through the *Corporate Budget for F.Y. 2022* intends to apply the sum of *Twenty-Five Million Seventy-Seven Thousand Nine Hundred Seven pesos (PHP 25,077,907.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for the *Emergency Repair of Rock Embankment and Restoration of Affected Structure at Port of Masao (NRP-AGN-03-22)*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Philippine Ports Authority – Port Management Office of Agusan* now invites bids for the above Procurement Project. Completion of the Works is required *within two hundred forty calendar days (240 CD)*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *Philippine Ports Authority – Port Management Office of Agusan* and inspect the Bidding Documents at the address given below from *8:00 am to 5:00 pm*.
5. A complete set of Bidding Documents may be acquired by interested bidders on *October 25, 2022*, from given address and website/s below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of twenty-five thousand pesos only (Php 25,000.00)*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees by *submitting the second copy of official receipt to the BAC Secretariat in the address given below*.
6. The *Philippine Ports Authority – Port Management Office of Agusan* will hold a Pre-Bid Conference on *November 2, 2022, 9:00 am* at *PPA-PMO Agusan Conference Room, Talisay, Nasipit, Agusan del Norte*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before *November 14, 2022, 8:00 am*. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 16**.

9. Bid opening shall be on *November 14, 2022, 9:00 am* at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. Prospective bidders must possess a valid PCAB license and registration of at least MEDIUM "A" (License Category B) for Port, Harbor or Offshore Engineering.
11. The *Philippine Ports Authority – Port Management Office of Agusan* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
