A complete set of Bidding Documents may be purchased by interested Bidders from the address below upon payment of a non-refundable fee of Twenty Five Thousand Pesos (**Php25,000.00**) inclusive of VAT.

Prospective bidders should possess a valid PCAB License and registration particulars applicable to the type and cost of the contract to be bid, have key personnel and equipment exclusively available for the prosecution of the contract as listed in Item C above, and must have completed a similar contract and with the same major categories of work as the contract to be bid and receipt of bids with a value of at least **50%** of the approved budget for the contract to be bid, updated to current prices using the NSO price indices, and must meet the other eligibility, technical/project, and

financial requirements and other requirements stated in the Eligibility Statement Form and the Bidding Documents.

Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criteria as specified in the IRR of RA 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships or organizations with at least 75% interest or outstanding capital stock belonging to citizens of the Philippines.

Similarly, the PPA PMO-Surigao assumes no responsibility, whatsoever, to compensate or indemnify the bidders of any expenses incurred in the preparation of their bids.
