The Philippine Ports Authority – Port Management Office of SOCSARGEN, through the Corporate Budget for the contract approved by the governing Boards for CY 2019 intends to apply the sum of PESOS: Thirty Eight Million Six Hundred Two Thousand Three Hundred Seventy Four Pesos and 88/100 Only (P 38,602,374.88) Inclusive of 12% VAT being the Approved Budget for the Contract (ABC) to payments under the contract for the PROPOSED CONSTRUCTION OF PARKING AREA, COVERED COURT, PM'S QUARTER AND DRAINAGE SYSTEM AT PORT OPERATIONS BUILDING, PORT OF GENERAL SANTOS, MAKAR WHARF, GENERAL SANTOS CITY. Completion of the Works is required to be completed within Four Hundred Eighty (480) Calendar Days. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using <u>non-discretionary</u> "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

- Interested bidders may obtain further information from the Secretariat of the BAC, Philippine Ports Authority – Port Management Office of SOCSARGEN and inspect and procure the Bidding Documents at the address given below from 8:00 a.m. to 5:00 P.M., Monday to Friday.
- A complete set of Bidding Documents may be acquired by interested bidders on <u>May 7,</u> 2019 up to the deadline for the submission and receipt of bids from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to

the latest Guidelines issued by the GPPB, in the amount of Twenty Five Thousand Pesos (P 25,000.00) plus 12% VAT.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- The Philippine Ports Authority Port Management Office of SOCSARGEN Bids and Awards Committee will hold a Pre-Bid Conference on <u>May 15, 2019, 9:00</u> <u>A.M.</u> at PPA- PMO SOCSARGEN, Port Operations Building - Conference Room #2, Makar Wharf, Labangal, General Santos City, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before <u>9:00 A.M., May 28, 2019</u> at the PPA Port Management Office of SOCSARGEN, Port Operations Building, Lobby Area, Labangal, General Santos City.
