



**REQUEST FOR EXPRESSION OF INTEREST FOR THE
CONDUCT OF TOPOGRAPHIC/HYDROGRAPHIC
SURVEY FOR THE FOLLOWING PORTS: (1) PORT OF
GENERAL SANTOS; (2) PORT OF GLAN; (3) PORT OF
MABILA; (4) PORT OF KALAMANSIG**

1. The **Philippine Ports Authority - Port Management Office –SOCSARGEN**, through the **PPA Corporate Budget for the contract approved by the governing Boards for CY 2022**, intends to apply the sum of **One Million Seventy Five Thousand Six Hundred Sixty Three Pesos Only (P 1,075,663.00) Inclusive of 5% VAT** being the Approved Budget for the Contract (ABC) to payments under the contract **CONDUCT OF TOPOGRAPHIC/HYDROGRAPHIC SURVEY FOR THE FOLLOWING PORTS: (1) PORT OF GENERAL SANTOS; (2) PORT OF GLAN; (3) PORT OF MABILA; (4) PORT OF KALAMANSIG: CS-SSG-01-2022**. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
2. The **Philippine Ports Authority - Port Management Office –SOCSARGEN** now calls for the submission of eligibility documents for the **CONDUCT OF TOPOGRAPHIC/HYDROGRAPHIC SURVEY FOR THE FOLLOWING PORTS: (1) PORT OF GENERAL SANTOS; (2) PORT OF GLAN; (3) PORT OF MABILA; (4) PORT OF KALAMANSIG: CS-SSG-01-2022**. Eligibility documents of interested consultants must be duly received by the BAC Secretariat on or before **9:00 A.M., June 13, 2022** at any of the following: (i) **manual submission at the office address as indicated below; (ii) online or electronic submission as indicated below; or (iii) both**. Applications for eligibility will be evaluated based on a non-discretionary “pass/fail” criterion.
3. Interested bidders may obtain further information from **Philippine Ports Authority - Port Management Office –SOCSARGEN** and inspect the Bidding Documents at the address given below during office hours from **8:00 A.M. to 5:00 P.M., Monday to Friday**.
4. A complete set of Bidding Documents may be acquired by interested Bidders on **June 6, 2022 up to the deadline for the submission and receipt of bids** from **given address and website/s below** and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (P 5,000.00) plus 12% VAT**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees **in person or through the email address provided in this Request for Expression of Interest**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

5. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", and its Implementing Rules and Regulations (IRR). The short list shall consist of prospective bidder/s who will be entitled to submit bids. The criteria and rating system for short listing are:

A. Applicable experience of the firm (minimum of 3 years)	
A.1 Records of previous engagement in quality of performance in similar project	50 points

B. Qualification of personnel who may be assigned to the job vis-à-vis extent and complexity of the undertaking	
B.1 Licensed Geodetic Engineer: General qualification and competence including education and training, nature and length of experience;	15 points
B.2 Instrument man: General qualification and competence including education and training, nature and length of experience;	5 points
B.3 Survey aide: General qualification and competence including education and training, nature and length of experience;	5 points
B.4 CAD Operator: General qualification and competence including education and training, nature and length of experience;	5 points

C. Current work load of relative capacity	
C.1 Licensed Geodetic Engineer: Types of position held, time with the firm; Suitability to perform the duties of the particular assignments.	8 points
C.2 Instrument man: Types of position held, time with the firm. Suitability to perform the duties of the particular assignments.	4 points
C.3 Survey aide: Types of position held, time with the firm. Suitability to perform the duties of the particular assignments.	4 points
C.4 CAD Operator: Types of position held, time with the firm. Suitability to perform the duties of the particular assignments.	4 points

OVERALL TOTAL 100 points

Bidders with at least fifty (50) points rating shall be qualified for short-listing.

6. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the IRR of RA 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.


7. The Procuring Entity shall evaluate bids using the Quality Based Evaluation (QBE) procedure. The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.
8. The contract shall be completed within **Forty-Five (45) calendar days exclusive of travel time.**
9. The **Philippine Ports Authority - Port Management Office –SOCSARGEN** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
