



## INVITATION TO BID

DOTr Tourism and Social Reform-Related Port Project

### CONSTRUCTION OF DITA COMMUNITY PORT

Barangay Dita, Zamboanga City  
(ZAM-PGEPSC-02-2022/EP-02-2022)

The Philippine Ports Authority, Port Management Office of Zamboanga (PPA, PMO-Zamboanga), through the 2019 DOTr GAA MOA, intends to apply the sum of ₱29,407,315.54 (inclusive of VAT), being the Approved Budget for the Contract (ABC) to payments under the contract for the DOTr Tourism and Social Reform-Related Port Project - Construction of Dita Community Port, Barangay Dita, Zamboanga City with Project Identification Number: ZAM-PGEPSC-02-2022/EP-02-2022. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Philippine Ports Authority, Port Management Office of Zamboanga now invites bids for the above Procurement Project. Completion of the Works is required 270 calendar days. Bidders should have completed a single largest contract, equivalent to at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Interested bidders may obtain further information from the Philippine Ports Authority, Port Management Office of Zamboanga Bids and Awards Committee (BAC) and inspect the Bidding Documents at the given address starting March 8, 2022, 8:00 AM to 5:00 PM, Monday to Friday.

A complete set of Bidding Documents may be acquired by interested bidders from March 8, 2022 to April 1, 2022 at the given address and PPA Website (downloadable) upon payment of the applicable fee for the Bidding Documents, pursuant to GPPB Guidelines, in the amount of TWENTY FIVE THOUSAND PESOS (₱ 25,000.00). The PPA, PMO-Zamboanga allow the bidder to present its proof of payment for the fees in person on or before the submission of Bids.

The Philippine Ports Authority, Port Management Office of Zamboanga Bids and Awards Committee (BAC) will hold a Pre-Bid Conference on March 17, 2022, 10:00 AM at the PPA Conference Room, 2<sup>nd</sup> Floor Admin. Bldg., Port of Zamboanga, Zamboanga City, and/or through webcasting via Zoom, which shall be open to prospective bidders upon request.

Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before 10:00 AM of April 1, 2022. Late bids shall not be accepted.

All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the bidding documents.

Bid opening shall be on April 1, 2022 at 10:00 AM, PPA Conference Room, 2<sup>nd</sup> Floor Admin Bldg, Port of Zamboanga, Zamboanga City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the given address. Late bids shall not be accepted.

The Philippine Ports Authority, Port Management Office of Zamboanga reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
