



INVITATION TO BID

Repair of Damaged Riprap, Stair Landing & Concrete Reblocking
Port of Ipil, TMO Zamboanga Sibugay
(ZAM-PGEPCS-07-2019/EP-05-2019/NRP-ZBO-05-19)

The Philippine Ports Authority, Port Management Office of Zamboanga (PPA, PMO-Zamboanga), through the Corporate Funds of the Authority for CY 2019, intends to apply the sum of ₱9,356,620.72 being the Approved Budget for the Contract (ABC) to payments under the contract for the Repair of Damaged Riprap, Stair Landing & Concrete Reblocking, Port of Ipil, TMO Zamboanga Sibugay (ZAM-PGEPCS-07-2019/EP-05-2019/NRP-ZBO-05-19). Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Philippine Ports Authority, Port Management Office of Zamboanga now invites bids for I. Demolition and disposal works – 1,054 cu.m., II. Supply & Place-in Core Rocks/Boulders (25-50kgs) – 396.75 cu.m., III. Supply & Place-in Rocks/Boulders (100-200kgs) - Stair Stabilizers – 109.62 cu.m., IV. Concreting of damaged structures (retaining walls, grouted riprap cover, stair landing, and concrete curb): a. Reinforcement - 13,066.70 kgs, b. Concrete – 186.59 cu.m., V. Concrete Reblocking of Damaged Pavement: a) Sub-Base Preparation - 845.52, b) Aggregate Sub-Base Course (Item 200) - 291.70 cu.m., c) Aggregate Base Course (Item 201) - 243.09 cu.m., d) Portland Cement Concrete Pavement – 845.52 sq.m. Completion of the Works is required in 211 calendar days. Bidders should have completed a contract similar to the above Project, equivalent to at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the Philippine Ports Authority, Port Management Office of Zamboanga Bids and Awards Committee (BAC) and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM, Monday to Friday.

A complete set of Bidding Documents may be acquired by interested bidders starting November 7, 2019 from the address below and upon payment of the applicable fee for the Bidding Documents in the amount of ELEVEN THOUSAND TWO HUNDRED PESOS (P11,200.00), VAT inclusive.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

The Philippine Ports Authority, Port Management Office of Zamboanga Bids and Awards Committee (BAC) will hold a Pre-Bid Conference on November 15, 2019 at 10:00 AM at the PPA Conference Room, 2nd Floor, Admin. Bldg., Port of Zamboanga, Zamboanga City which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before 10:00 AM of December 3, 2019. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the bidding documents.

Bid opening shall be on December 3, 2019 at 10:00 AM at the PPA Conference Room, 2nd Floor, Admin. Bldg., Port of Zamboanga, Zamboanga City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
