



INVITATION TO BID (SECOND BIDDING)

Repair of Powerhouse Building including CFS Building Electrical System and Walk Shed Led Lightings, Port of Zamboanga, Zamboanga City
(ZAM-PGEPCS-06-2019/EP-04-2019/NRP-ZBO-03-19)

The Philippine Ports Authority, Port Management Office of Zamboanga (PPA, PMO-Zamboanga), through the Corporate Funds of the Authority for CY 2019, intends to apply the sum of ₱15,283,416.82 being the Approved Budget for the Contract (ABC) to payments under the contract for the Repair of Powerhouse Building including CFS Building Electrical System and Walk Shed Led Lightings, Port of Zamboanga (ZAM-PGEPCS-06-2019/EP-04-2019/NRP-ZBO-03-19). Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Philippine Ports Authority, Port Management Office of Zamboanga now re-invites bids for the following repair works: I. Demolition/Disposal Works - 1.00 Lot, II. Concrete Works - 12.42 cu.m., III. Masonry Works - 111.84 sq.m., IV. Steel and Metal Works - 10,306.50 Kgs, V. Roofing and Tinsmithry Works - 550.62 sq.m., VI. Ceiling Works - 111.69 m², VII. Tiling Works - 261.64 sq.m., VIII. Electrical Works - 1.00 Lot, IX. Plumbing and Sanitary Works - 1.00 Lot, X. Doors and Windows - 1.00 Lot, XI. Painting Works - 2,386.74 sq.m. Completion of the Works is required in 281 calendar days. Bidders should have completed a contract similar to the above Project, equivalent to at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the Philippine Ports Authority, Port Management Office of Zamboanga Bids and Awards Committee (BAC) and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM, Monday to Friday.

A complete set of Bidding Documents may be acquired by interested bidders starting December 4, 2019 from the address below and upon payment of the applicable fee for the Bidding Documents in the amount of TWENTY EIGHT THOUSAND PESOS (P28,000.00), VAT inclusive.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

The Philippine Ports Authority, Port Management Office of Zamboanga Bids and Awards Committee (BAC) will hold a Pre-Bid Conference on December 12, 2019 at 10:00 AM at the PPA Conference Room, 2nd Floor, Admin. Bldg., Port of Zamboanga, Zamboanga City which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before 10:00 AM of December 26, 2019. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the bidding documents.

Bid opening shall be on December 26, 2019 at 10:00 AM at the PPA Conference Room, 2nd Floor, Admin. Bldg., Port of Zamboanga, Zamboanga City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The Philippine Ports Authority, Port Management Office of Zamboanga reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
